- Nominee should be in good standing such as no outstanding fees owing to TAPA.
- IABs are excluded from participation.
- Nominees should be aware and be committed to commit and discharge their duties as the BOD of TAPAAPAC upon elected.

- Endorsements within the online application are to be accurate and completed.
- Forms **including** all necessary endorsements are to be received within nomination period.
- Comply with the nominee and membership requirements outlined above.


